The MTA's four (4) Public Hearings on its proposed toll-tax scheme – what it calls “proposed tolling structure of congestion pricing for the Central Business District,” modeled on recommendations made by the Traffic Mobility Review Board established by state law – take place as follow:

- ▶ Thursday, Feb. 29, at 6:00 p.m. – 10:00 p.m.
- ▶ Friday, March 1, at 10:00 a.m. – 2:00 p.m.
- ▶ Monday, March 4, at 10:00 a.m. – 2:00 p.m.
- ▶ Monday, March 4, at 6:00 p.m. – 10:00 p.m.

at MTA Headquarters, 2 Broadway, 20th Floor – William J. Ronan Board Room, New York, NY 10004. Testify in person or via Zoom.

Registration for each Public Hearing begins one week in advance (February 22, February 25 and February 28), and closes 30 minutes following the start of each hearing. To register, please visit this page one week (February 22, February 25 and February 28) in advance of the hearing you would like to attend, or call the Public Hearing Hotline at (646) 252-6777. Telephone agents are available daily from 6:00 a.m. through 10:00 p.m.

Registered speakers have two (2) minutes to speak. Public comments are limited to 240 minutes per hearing (approx. 120 speakers). Those registered to speak may join in person, or online or by phone as follows:
